FROM NJ Turnpike

Exit 8 to Route 33 E. for ¼ mile to Route 133 W. At the end of Route 133 bear right to Route 571 W. At second traffic light make a left turn onto Southfield Road. Cranbury Golf Club is 1 mile down on the right.

FROM ROUTE 1

East at Princeton Circle to Route 571. Follow signs to Hightstown. Turn right at the gas station (Southfield Road). Cranbury Golf Club is 1 mile down on the right.

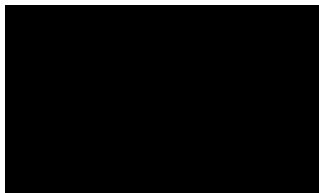
Registration is on a first-come, first-served basis.
